## **CHANGE OF COMPANY NAME, STOCK SHORT NAME, COMPANY LOGOS AND COMPANY WEBSITE**

References are made to the announcement of Jsmart Technologies Group Limited (formerly known as “**Daisho Microline Holdings Limited**”) (the “**Company**”) dated 24 April 2026, the notice of the SGM and the circular (the “**Circular**”) of the Company to the Shareholders both dated 6 May 2026 in relation to, among others, the Proposed Change of Company Name.

Unless the context otherwise requires, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

### **CHANGE OF COMPANY NAME**

The Board is pleased to announce that following the passing of a special resolution approving the Proposed Change of Company Name by the Shareholders at the SGM held on 22 May 2026, the certificate of change of name and the certificate of secondary name (collectively, the “**Certificates**”) were issued by the Registrar of Companies in Bermuda certifying that the name of the Company has been changed from “Daisho Microline Holdings Limited” to “Jsmart Technologies Group Limited”, and the Chinese name “金安具身智能科技集團有限公司” has been registered as the secondary name in Chinese to replace the former Chinese name “大昌微綫集團有限公司”, which was for identification purpose only (the “**Change of Company Name**”), both with effect from 28 May 2026 pursuant to the Certificates issued by the Registrar of Companies in Bermuda on 1 June 2026. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 12 June 2026 confirming the registration of the Company’s new English name as “Jsmart Technologies Group Limited” and Chinese name as “金安具身智能科技集團有限公司” in Hong Kong under Part 16 of the Companies Ordinance (Cap. 622 of the Laws of Hong Kong).

## **CHANGE OF STOCK SHORT NAME**

Following the Change of Company Name, the stock short name of the Shares for trading on the Stock Exchange will be changed from “DAISHOMICROLINE” to “JSMART TECH” in English and from “大昌微綫集團” to “金安智能” in Chinese with effect from 9:00 a.m. on Thursday, 25 June 2026. The stock code of the Company on the Stock Exchange remains unchanged as “00567”.

## **CHANGE OF COMPANY WEBSITE**

The Board further announces that the Company’s website will be changed from “www.irasia.com/listco/hk/daisho” to “www.jsmartech.hk” with effect from 25 June 2026.

## **EFFECT OF THE CHANGE OF COMPANY NAME AND THE CHANGE OF COMPANY LOGOS**

The Change of Company Name and the change of the logos of the Company will not affect any rights of the Shareholders or the Group’s daily business operation and its financial position.

All existing certificates of securities in issue bearing the former name and the former logo of the Company will continue to be evidence of legal title to such securities and the existing share certificates of the Company will continue to be valid for trading, settlement, registration and delivery purposes. There will not be any arrangement for exchange of the existing share certificates for new share certificates bearing the new name and the new logo of the Company. New share certificates of the securities of the Company will be issued in the new name and logo of the Company with effect from 25 June 2026.
